LIMITED FACE-TO-FACE CLASSES IMPLEMENTATION IN SIXTEEN (16) SCHOOLS AND THE PROGRESSIVE EXPANSION OF LIMITED FACE-TO-FACE CLASSES

- 1. In view of the latest downgrading of Alert Level Classification of the Province of Occidental Mindoro from Level 3 to Level 2 starting February 16, 2022, and pursuant to DepEd Memorandum No. 71, s. 2021 titled *Preparations for the Pilot Face-to-Face, Expansion, and Transitioning to New Normal*, DM No. 72, s. 2021 titled *Accountability Map for the Preparations for the Implementation of the Limited Face-to-Face Learning Modality,* and DM 85, s. 2021 titled *Preparations for the Implementation of the Expanded Phase of Face-to-Face Classes*, the Schools Division Office of Occidental Mindoro announces the opening of sixteen (16) schools on February 21, 2022 for the limited Face-to-Face Classes Implementation.
- 2. The objectives of the implementation of the limited F2F classes include the following:
 - a. To address the issue on disruption to instructional time in the classroom as it has a severe impact on the child's ability to learn;
 - b. To close the gap between the poorest households than those from the richest in issue regarding the risk of dropping out of school;
 - c. To help eliminate the increasing risk of child trafficking, online and offline sexual abuse and exploitation of children, teenage pregnancies, child marriages, violence and other threats;
 - d. To continue the provision of school-based services to children such as immunization, school feeding, mental health and psychosocial support, and dental health care; and

Relative to this, the SDO Monitoring Team including all District Supervisors, some select DFTAT members, and concerned School Heads of the 16 schools shall participate in a meeting to be facilitated by the Composite Team on February 17, 2022, 1:30 PM onwards via Zoom platform, link shall be sent via group chat, to gather updates and provide guidance on issues and concerns regarding the pilot implementation of F2F classes in the Division.
- 5. In view of the progressive expansion of the limited F2F classes which is open to all, and based on Division Memorandum No. 52, s. 2022 titled *Submission of School Self-Assessment Tool (SSAT) for the Implementation of Expanded Face-to-Face Classes in the Schools Division of Occidental Mindoro*, all are encouraged to coordinate with the Local Government Units and Rural Heath Units as well as with all stakeholders and partners to draw support in preparation of the classrooms, schools, community and municipality in the mass implementation of the F2F classes, and adopt to the New Normal. School Heads are likewise advised to seek support from peers and colleagues to share their best practices in implementing the F2F classes.
