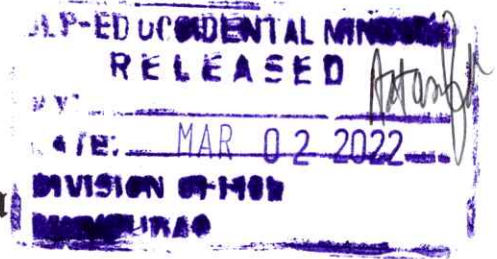

1. 4. Said template shall be accomplished every **Wednesday morning** of the week starting **March 2, 2022**.

Further, this Office also informs all concerned that the Composite Team for the Implementation of Face-to-Face Classes (*see enclosure*) shall conduct the monitoring, evaluation and validation of the public and private schools participating in the Progressive Expansion of Face-to-Face Classes starting **March 2, 2022**.
