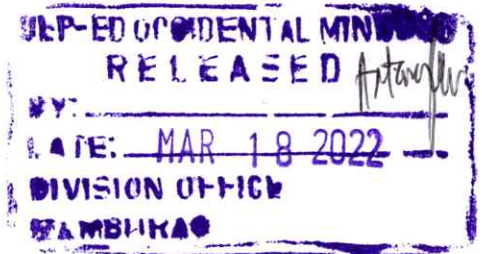

**IMPLEMENTATION OF THE FINANCIAL EDUCATION POLICY  
IN ALL PUBLIC AND PRIVATE SCHOOLS AND LEARNING CENTERS**

1. In compliance with DepEd Order No. 022, s. 2021 titled **Financial Education Policy** issued on June 3, 2021 which is pursuant to pertinent provisions of Republic Act (RA) No. 10922 or the Economic and Financial Literacy Act of 2016 and RA 10679 or the Youth Entrepreneurship Act of 2015, the Schools Division of Occidental Mindoro advises all public and private elementary, secondary schools, and learning centers to fully implement the said DepEd Order.
2. The policy aims to intensify the integration of Financial Education in the K to 12 Basic Education Curriculum in various disciplines across grade levels and targets to enhance the financial literacy and financial capability of all learners, public school teachers, and DepEd personnel to make sound financial decisions that lead to financial health and financial inclusion (*paragraphs 2-3, DO No. 022, s. 2021*). This supports country's vision **Ambisyon Natin 2040: Matatag, Maginhawa, at Panatag na Buhay and that of the Sustainable Development Goals (SDGs)**.
3. Trained school heads and teachers last March 15-16, 2022 conducted at Mamburao, Occidental Mindoro, and those who will be capacitated in the district/school level shall provide assistance in the implementation of the policy. Teachers are expected to integrate the core messages in the K to 12 Curriculum. Monitoring and evaluation in the school level must be conducted as planned.
4. Any training-related expenses, meals and travelling expenses of participants and members of the program management team in a face-to-face mode of delivery shall be charged to school MOOE or other sources of funds subject to the usual budgeting, accounting, and auditing rules and regulations.
5. Immediate dissemination of and strict compliance with this memorandum are earnestly desired.
