Department Orders, Memoranda and other issuances are published in the official DepEd website [www.deped.gov.ph](http://www.deped.gov.ph). For some reasons, some were not given attention. Some DepEd Orders which need to be downloaded and understood are the following:

On the regulation of operations of the Parent-Teachers Association in the schools as well as the Municipal and Provincial Federation of PTA, we have **DO 13, s. 2022 - Omnibus Guidelines on the Regulation of Operations of the Parent-Teacher Associations**. This shall serve as the guide of the schools, the PTAs, and the SDO-SGOD Social Mobilization and Networking Section in providing support to learning delivery.

While the Central Office allocates and download financial assistance to the Schools Division Office and some Secondary Schools - Implementing Units, the **DO 12, s. 2022, Policy Guidelines for the Provision of Learning Resources and Needed Devices and Equipment and Funding Relevant Activities for the Implementation of Basic Education-Learning Continuity Plan** serves as reference in the prioritization of eligible resources and equipment necessary in the implementation of the BE-LCP.

In case Schools Division Offices and elementary schools are troubled in selecting the supplemental foods to be procured in the implementation of the SBFP, **DO 10, s. 2022 - Supplemental Guidelines on DepEd Order No. 031, s. 2021** (Operational Guidelines on the Implementation of the School-Based Feeding Program) is provided as additional clarificatory provisions in the issued DO 22, 23, and 37, s. 2020.

DepEd sees the great and significant role of private schools to provide education services to people. Anent this, policies, guidelines and programs and projects are implemented to assist them in their operation. **DO 9, s. 2022 - Creation of the Private Education Office in the Department of Education Central Office** and **DO 6, s. 2022 - Reconstitution of the Government Assistance and Subsidies Composite Team** were issued to strengthen the link between the agency and the private sector.

Aimed at quality, clean and transparent operation and governance, management and supervision of the Department, **DO 7, s. 2022 - Creation of Anti-Corruption Committees in the Central, Regional, and Schools Division Offices of the Department of Education**. It introduces the *Project KASANGGA: Aksiyon Laban sa Korapsiyon* of the Department which is anchored on the policy guidelines in the operationalization of the Anti-Corruption Committees.
