Per DepEd Order No. 17, s. 2022 titled "Guidelines on the Progressive Expansion of Face to Face Classes", Joint Memorandum Circular No. 001, s. 2022 dated April 6, 2022 with the subject "Revised Operational Guidelines on the Progressive Expansion of Face to Face Learning Modality", DepEd Memorandum No. 30, s. 2022 titled "Dissemination of the Revised School Safety Assessment Tool for the Progressive Expansion of the Face to Face Classes", and anchored on one of the Agenda under Executive Order No. 166 titled "Adopting the Ten-Point Policy Agenda to Accelerate and Sustain Economic Recovery from the COVID-19 Pandemic, and Directing a Whole-of-Government Approach to Align all Economic Recovery Programs and Measures of the National Government", i.e. "4. Resume Face-to-Face Learning. The National Government shall strengthen efforts towards the safe resumption of face-to-face learning, and capitalize on the gains achieved in the conduct of pilot face-to-face schooling", the Schools Division of Occidental Mindoro shall conduct a **Virtual Orientation on the Guidelines on the Progressive Expansion of Face-to-Face (F2F) Learning Modality** on April 18, 2022 at 9:00 AM to 12:00NN via Zoom.

2. The activity aims to provide a clear and common understanding of the policy guidelines on the progressive expansion of F2F classes along with other guidelines in support of the program implementation.

During the validation and provision of technical assistance, the composite team shall work with the representatives from each school in addressing the issues, challenges, and concerns in the preparation for the division-wide program implementation. Each school shall bring the results of the Revised SSAT and all other documents requirements for the implementation of F2F classes.

6. Any expense related to the conduct of the above-cited activities shall be charged to local funds/School MOOE subject to the usual government auditing and accounting rules and regulations.
