Information and Communication Team	Provide necessary information, intelligence and updates regarding DRRM for the prevention and mitigation stage of DRRM Plan	
Curriculum Monitoring/Assessment Team	Take charge of the curriculum integration of DRRM in education	
Facilities Assessment Team	Take charge in the monitoring and assessment of school buildings as part of the Contingency Plan	
Pre-& Post Disaster Monitoring Team	Assigned In the monitoring and assessment before and after emergencies	
Transport and Mobilization Team	Take charge in the transportation during the response phase relative to DRRM & Contingency Plans	
Safe & Security Team	Ensure the safety & security of personnel and students during and after calamity	
Medical Supply/Health Team	Administer First Aid & proper medication during rescue operation	
Logistics	Oversee relief assistance of the unit in terms of providing basic services to the victims	
Relief Assistance Committee	Call for donations specifying assistance needed by the recipients and lead the distribution of donations on the ground in
