ESTABLISHMENT OF HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMP SB) AND ITS SUB-COMMITTEES

Public Elementary and Secondary School Heads

1. Pursuant to DepEd Order No. 19, s. 2022 titled *The Department of Education Merit Selection Plan*, and DepEd Memorandum No. 41, s. 2022 titled *Transitory Measures on the Implementation of DepEd Order No. 19, s. 2022*, the Schools Division of Occidental Mindoro shall establish the **Division Human Resource Merit Promotion and Selection Board** at the different levels of governance with their corresponding sub-committees.
2. Relative to this, each school / district is requested to submit on or before June 3, 2022 the newly-established and/or organized associations, organizations, or clubs for different levels of governance as:
 - a. First level positions
 - b. Second level positions, including second level executive/managerial positions
3. All associations, organizations or clubs that shall be established/reestablished or organized/reorganized are requested to elect officers and board members that include but are not limited to:
 - a. Chairperson / President
 - b. Vice Chairperson / Vice President
 - c. Members of the Board of Directors (at least 5)
 - d. Committee Chairperson and Members (at least 2)
 - e. Secretary
 - f. Public Information and Communications Officer
4. Schools are highly encouraged to come up with personnel (teaching and non-teaching) associations, organizations, and/or clubs, identify the roles and responsibilities or duties and functions, and create their corresponding Constitutions and By-Laws. They shall elect representatives to sit in different school committees, i.e. School Selection Committee.

5. Moreover, all associations, organizations, and clubs should have their counterparts at the District level as deemed necessary and applicable. They shall form the Division Sub-Committees, whenever applicable.

6. Upon submission of the list of officers/board of directors representing the different groups at the school and district levels, there will be an election of officers at the Division Level. The election shall be facilitated by the Administrative Section – Personnel Unit and the SGOD - Human Resource Development Section. They include:

- a. School Heads group (Elementary, e.g. PESPA)
- b. School Heads group (High School, e.g. NAPSSHI)
- c. Teachers group (Elementary)
- d. Teachers group (High School)
- e. Non-Teaching group (First Level)
- f. Non-Teaching/Related-Teaching (Second Level)

7. All personnel in the Division Office are also expected to reorganize their associations for the first and second levels. The elections shall be facilitated by the Chief Education Supervisor (SGOD) and Administrative Officer V (Administrative Section).

8. The following suggested timeline of activities relative to establishment/reestablishment and organization/reorganization of associations, organizations, and clubs may be followed:

Activity	Suggested Dates
Election of Officers/Board in the School Level	May 16-20, 2022
Submission of List of Officers/Board Members to District Level	May 20, 2022
Election of Officers/Board in the District Level	May 23-27, 2022
Submission of List of Officers/Board Members to Division Level	May 27, 2022
Election of Officers/Board in the Division Level	May 30 - June 3, 2022
Recognition (Oath Taking) of Officers/Board Members in the Division Level	June 7, 2022

9. All expenses relative to the conduct of the aforementioned activities may be charged to Local Funds subject to availability, and to the usual government auditing and accounting rules and regulations.
