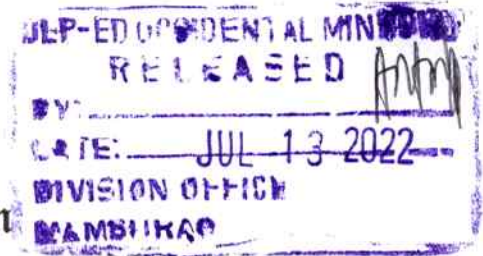

ORIENTATION FOR THE 4TH NATIONAL COMPETITION ON STORYBOOK WRITING

1. In reference to the Regional Coordination Meeting of LRMS Personnel on Storybook Writing Contest held last July 1, 2022, this Office shall conduct a Division Orientation for the 4th National Competition on Storybook Writing on July 22, 2022 at 9:00AM at PTMSMNHS, Bagong Sikat, San Jose, Occidental Mindoro.
 2. This activity aims to:
 - a. enhance skills and awaken greater interest in writing & designing storybooks; and
 - b. orient the interested participants on the guidelines, categories, and mechanics for the upcoming 4th National Competition on Storybook Writing; and
 - c. prepare the storybook writers and illustrators for submission of entries to the regional/national level competition.
 3. To ensure safety of everyone, participants are advised to wear face mask and observe health standard protocols within the whole duration of the activity.
 4. The list of facilitators and members of the Technical Working Group (TWG) can be found in Enclosure 1.
 5. This is a **LIVE-OUT** activity. Food, hotel accommodation, traveling and other incidental expenses of the participants and facilitators shall be charged against school MOOE or local funds subjects to the usual accounting, budgeting, and auditing rules and regulations.

6. **Vacation Service Credit** shall be granted to all participants who will attend the activity on July 22, 2022 per **Joint Circular No.2, s.2014** of the Civil Service Commission (CSC) and the Department of Budget and Management (DBM), i.e, **“Non-Monetary Remuneration for Overtime Services rendered during holidays and weekends”** and **DO No.53, s.2003, “Updated Guidelines on grant of Vacation Service Credits to Teachers”**.
7. Immediate and wide dissemination of the contents of this memorandum is desired.
