3. All Administrative Officers II in the districts and schools are tasked to serve as the Sub-Committee Secretariat whose functions include:
- a. Ensure that all applicants in the districts/schools are informed of the schedule of their interview and demonstration teaching;
 - b. Take charge in checking the attendance of the panel members and applicants per day, and the proceedings of both the interview and demonstration teaching;

- c. Tabulate and consolidate scores from the panel members, and have the documents signed by the panel members;
- d. Safely secure and keep the documents and ensure confidentiality of the results of the processes; and
- e. Endorse the same to the Chairperson of the sub-committee, and aid in transmitting them to the Schools Division Office, Attn: Personnel Section.

4. Applicants who request for retention of their existing points for interview and demonstration teaching must present the copy of the page of the last RQA highlighting the name and their corresponding points for easy recording and validation. They need to report to the designated venue of the interview and demonstration teaching for attendance and presentation of the proof of their claim.

5. The host schools, Sablayan Comprehensive NHS, San Jose National High School, and all schools identified as venue by our District Supervisors are requested to make necessary preparations for the conduct of the activities, including a holding area when deemed needed.

6. The Division Personnel Selection Board members and its secretariat are tasked to coordinate to the respective host schools, sub-committee members, and monitor and supervise the conduct of the activities. Master Teachers who will serve as panel during the demonstration teaching shall be given service credits for the duration of the process.

7. All expenses related to the conduct of these activities shall be charged to local funds subject to the usual government accounting and auditing rules and regulations.

8. Wide and immediate dissemination of the contents of this Memorandum is desired.
