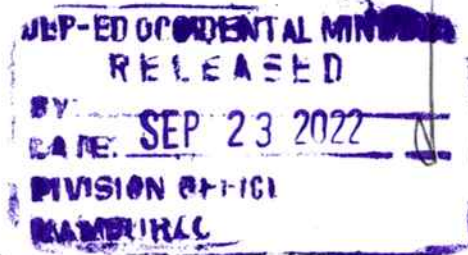

**REGIONAL MEMORANDUM**

**CAPACITY BUILDING ON GENDER AND DEVELOPMENT (GAD) RESPONSIVE PROGRAMS, PROJECTS, AND ACTIVITIES (PPAs)**

TO: **OIC, OFFICE OF THE ASSISTANT REGIONAL DIRECTOR

1. Republic Act No. 9710, otherwise known as the "Magna Carta of Women" mandates for the development of GAD Programs and Budgeting through GAD Planning which states: "*All agencies, offices, bureaus, SUCs, GOCCs, LGUs, and other government instrumentalities shall develop and implement GAD programs, projects and activities (PPAs) within the context of their mandates and budget for these through their annual GAD Plans and Budgets.*"
2. DepEd MIMAROPA as government agency shall follow the required conduct of a gender audit, gender analysis, and/or utilization of sex-disaggregated data, and shall utilize its GAD agenda from Central Office, which provides the agency GAD vision, mission, goals, outcomes, targets and corresponding PPAs to respond to women's issues and gender gaps or issues faced by the clients and constituents, including women and men employees.
3. With this, DepEd MIMAROPA Region through the Gender and Development Focal Point System shall conduct a **Capacity Building on Gender and Development (GAD) Responsive Programs, Activities, and Projects (PPAs)** on **August 30-31, 2022** and **September 01, 2022** within Metro Manila. Venue details to follow.
4. This activity aims to:
  - a. Deepen understanding on concept of gender mainstreaming and the use of gender analysis tools in crafting GAD responsive PPAs;
  - b. Strengthen the use of GMEF, HGDG, and SDD on data analysis and its results in the preparation of GAD Plans and Budget; and
  - c. Adopt best practices on Gender Mainstreaming through collaboration and workshop.
