**CONDUCT OF COMPETENCY ASSESSMENT FOR COMPUTER SYSTEMS

1. Relative to the Training on Computer Systems Servicing (CSS) NC II for EPP/TLE Teachers held last July 11-14, (Batch 1) and July 18-21 (Batch 2), respectively, a **Competency Assessment for Computer Systems Servicing (CSS) NC II Qualification** will be conducted by TESDA on October 14, 2022 at the Occidental Mindoro State College - San Jose Campus, San Jose, Occidental Mindoro.
2. This activity aims to:
 - a. expand the pool of TLE teachers with national certifications (NC II) on Computer Systems Servicing;
 - b. determine whether a teacher demonstrates competence in a given qualification as defined by its competency standards.
3. The List of Candidates Scheduled for Competency Assessment can be found in an enclosure to this Memorandum. They are required to bring 4 gb flashdrive to be used during the assessment.
4. This is a LIVE-OUT activity. An assessment fee amounting to One Thousand Forty Nine pesos (Php 1,049.00) shall be collected from each candidate. Traveling and other expenses relative to the conduct of this activity shall be charged against local funds subject to availability and to the usual accounting, and auditing rules and regulations.
