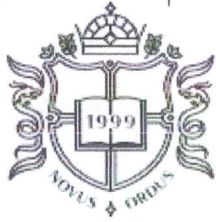

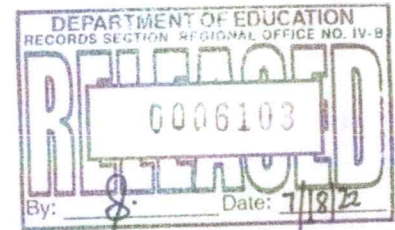

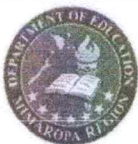

d. SAFE MANAGEMENT TRAINING for disaster risk reduction and management officers.

A 3-day training program for school disaster risk reduction management officers which introduces tools, frameworks, and practices locally and internationally to best support the transition of schools and division offices towards expanded face-to-face classes.
